**Whereas**, Associated Students, Inc. at Sacramento State (ASCSUS) is the sole representative voice of the more than 30,000 students at Sacramento State; and

**Whereas**, the Associated Students of California State University, Sacramento (ASCSUS) is committed to protecting the rights of free speech and assembly as guaranteed by the First Amendment of the United States Constitution; and

**Whereas**, SB 1287 (Glazer) seeks to implement restrictions within campus-based student codes of conduct that may infringe upon these rights by limiting the manner, time, and place of public protests and demonstrations on campuses; and

**Whereas**, these provisions within SB 1287 could potentially restrict the activities of student organizers and student organizations who rely on the ability to freely express and assemble for advocacy and educational purposes; and

**Whereas**, ASCSUS believes that such restrictions could undermine the educational mission of the segment by stifling the free exchange of ideas and hindering the development of critical thinking and civic engagement among students; and therefore be it

**Resolved**, that ASCSUS opposes SB 1287 as it currently stands due to its potential adverse effects on the constitutional rights of students to free expression and assembly; and be it

**Resolved**, that ASCSUS urges the California State Legislature to reconsider the implications of SB 1287 on the free exercise of First Amendment rights and to seek alternative measures that safeguard both campus safety and constitutional freedoms; and be it

**Resolved**, that this resolution reflects ASCSUS's dedication to fostering an environment that respects and promotes the diverse voices and activism of its student body; and be it

**Resolved**, ASCSUS opposes SB 1287 (Glazer); and be it finally

**Resolved**, that this resolution be distributed to Sacramento State President, Dr. Luke J. Wood; Chancellor of the California State University, Mildred Garcia; all 22 other CSU student body
